Memorandum of Understandings

Between

Highbury Quadrant Congregational Church London N5 2TE UK
and

Christian Social Uplift Organization (Regd) Pakistan (Project)

25th Oct, 2025

This Memorandum of Understanding ("MOU") sets forth the working relationship between HQCC ("Highbury Quadrant Congregational Church London") and Christian Social Uplift Organization Pakistan ("CSUO") regarding the partnership between the organizations in Pakistan. The spirit of this MOU is one of mutual respect and cooperation. Its purpose is to establish a clear understanding by the parties of the responsibilities, policies, and procedures of the partnership between HQCC and CSUO in Pakistan. This clarity will allow HQCC and CSUO to have a deep and meaningful impact in Pakistan. This MOU is valid from on October 25th, 2025 and extending until both parties are satisfied, unless earlier terminated pursuant to the terms of this MOU.

1. Relationship Managers.

- The relationship manager for HQCC will be Lt Col (Retd) Shahid Country Director for HQCC Pakistan projects.
- The relationship manager for CSUO will be Mr. Bruener B. Newton President.
- Either party may change its designated relationship manager by providing written notice to the other party.

2. HQCC Commitments. HQCC agrees to perform the following:

- To provide Donation (to be disbursed each month for all existing or new Projects) to develop, implement, and report on projects and trainings improving the economic development of marginalized communities and educational assistance to deserving students (schooling project), Health & Hygiene Projects, Formal & Non Formal Education and Technical Education in Pakistan.
- To pay each month donation for operating cost for the employment of staffers to help manage the implementation and reporting of all projects and programs.
- To maintain detailed financial and administrative reporting and documents.

- a. To Transfer designated funds (Donation) each month to Project Manager HQCC account for staff salaries and other project costs.
- b. To maintain detailed administrative reporting regarding the partnership's operations for reporting to the Pakistan government.
- c. To provide advice and guidance where necessary to improve or maintain the smooth operation of the partnership in Pakistan.
- d. To support vision and goals of HQCC and support them in independent operations.
4. Amendments. HQCC and CSUO agree to mutually approve any material change to the partnership, including termination of the partnership, and other changes deemed material by HQCC and CSUO.
5. Termination. HQCC and CSUO may terminate this MOU by mutual written consent. However, if the MOU is terminated, CSUO agrees to return any unspent funds with the exception of reasonable project termination costs.
6. General Provisions.
 - a. Each party agrees that during the term of this MOU and thereafter it will hold the other party's confidential information in confidence and protect it from unauthorized use and disclosure and will not disclose such confidential information to any third parties except as authorized in writing by the other party.
 - b. The relationship of the parties is that of two parties to a contract, and nothing in this MOU is intended to, or should be construed to, create a partnership, agency, joint venture, or employment relationship between the parties. Each party shall have full control of its operations and undertakings and shall be fully responsible for activities and duties carried out on its behalf.
 - c. If there is any misunderstanding or conflicts with regards to this MOU and its implementation, HQCC and CSUO will meet in good faith to seek to resolve the matter outside of a court or other formal judicial system.
 - d. Any notice required or permitted by this MOU shall be in writing and shall be delivered as follows with notice deemed given as indicated: (i) by personal delivery when delivered personally; (ii) by overnight courier upon written verification of receipt; (iii) by telecopy or facsimile transmission upon acknowledgment of receipt of electronic transmission; or (iv) by email at the address of the party listed below. Notice shall be sent to the addresses set forth below or such other address as either party may specify in writing.
 - e. The official text of this MOU shall be the English language, and such English text shall be controlling in all respects, notwithstanding any translation hereof required under the laws or regulations of another country. All notices, requests, communications, and proceedings under this MOU shall be in the English language. The official currency stated in this MOU will be PKR, and all payments shall be made in PKR
